



Little Amesbury Factsheet from September 2026 – Nursery and Pre-School Only

Please note that Pre-School (Nursery) fees are charged half termly in advance and on a sessional basis

Registration Fee - £120 (VAT does not apply)

The Registration Fee is payable to enroll your child for the school and is non-refundable. It does not guarantee your child a place at the school.

Acceptance Fee - £500 (VAT does not apply)

Once an offer of a place has been made by the school, receipt of the Acceptance Fee by the school guarantees your child's place. The Acceptance Fee is refundable when your child leaves the school, less any outstanding charges.

How Pre-School (Nursery) operates

Early Birds (for those not doing a Full Day)	7.45am to 8.15am
School Day	8.15am to 4.00pm
Twilight 1 session (for those not doing a Full Day)	4.00pm to 5.00pm – including hot tea
Twilight 2 session (for those not doing a Full Day)	5.00pm to 6.00pm – after tea
Full Day	7.45am to 6.00pm

Children attending Nursery or Pre- School must attend a minimum of two School Days per week (8.15am to 4.00pm).

Funding

At Little Amesbury we are delighted to offer up to 30 hours of funded childcare per week during Amesbury term-times to eligible families.

15 hours of funded childcare is available to all 3 and 4 year olds.

Funding applies from the term after your child turns 3 years old (as they join our Nursery Class) until the term in which they turn 5 years old (in our Reception class).

Six hours of funding is applied to each School Day or Full Day your child attends. To claim the full 30 hours of funding your child must attend for 5 days per week.

For those entitled to universal funding only, six hours of funding is applied to 2 days and three hours to a third day. To claim the full 15 hours of funding, your child must attend for 3 days per week.

Children transferring from Pre-School to Reception class continue to receive 30 hours of funding up to and including the term in which they turn 5 years old.

Fees

Early Birds in the Pre-Schol (Nursery) is charged at £8.75 per day including breakfast.

Twilight 1 in the Pre-School (Nursery) is charged at £14.75 per day including tea.

Twilight 2 in the Pre-School (Nursery) is charged at £12.00 per day.

Holiday Club

Holiday Club operates during all school holidays except for closures at Christmas, Easter and at the end of August/early September.

Charges are the same as for term-time sessions (as above). Surrey County Council funding does not apply.

Bookings can either be made for the academic year in advance or on a half-termly basis, with opportunities to book in advance of each half term and end of term.

Sessions are paid for in advance for each holiday period.
